- 5. We will look to see if we can get a printer to connect to the door entry system. On hold

- 7. A meeting between squash and the rec club to be arranged to discuss why squash does not receive any of the VAT refunded to the rec club for the gas and electricity we use.
- 8. We have been donated a replacement table tennis table. Due to access, it can only go on court 1. Door stops on courts 2 and 4 require re-positioning.
- A poster will be displayed and members have been notified through WhatsApp to the reviving of club night on a Tuesday starting 11<sup>th</sup> July. Courts 1 & 2 to be booked off.
  We will be looking into the possibility of using the two ty screeps in the passageway as revolving bill boards for club.
- 10. We will be looking into the possibility of using the two tv screens in the passageway as revolving bill boards for club information. **On Hold**
- 11. Both saunas have been turned off for July to gain an idea of the running costs.
- 12. From the county meeting, all clubs are to ensure their Safeguarding Officer and policies are easily found or obvious on their website and/or notice boards.
